### TOWN AND COUNTRY PLANNING ACT 1990

Proposed Pedestrianisation of a Highway at Millom, Cumbria

The Secretary of State for Transport hereby gives notice that on the application of the Copeland Borough Council he proposes to make an Order under section 249 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on a part of Market Square, Millom, Cumbria.

The proposed Order will contain provisions for permitting the use of that highway by vehicles being used:

1. (a) for police, ambulance or fire brigade purposes;

- (b) in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984.
- 2. Where the vehicle is:
  - (a) a vehicle being used by the local authority and local highway authority in pursuance of their statutory powers and duties;
  - (b) a vehicle being used in connection with the construction, alteration, maintenance or demolition of any premises adjacent to that highway;
  - (c) a vehicle having a maximum weight of 7.5 tons being used in connection with the delivery or collection of goods or merchandise to or from premises at the Market Hall via the Market Hall entrance.

During 28 days from 6th September 1994, copies of the draft Order and relevant plan may be inspected at the offices of Copeland Borough Council, Holborn Hill, Millom, Cumbria, and may be obtained, free of charge, from the Secretary of State (quoting Ref. TNW 5164/41/39/01) at the address stated below.

Within the above-mentioned period of 28 days, any person may by notice to the Secretary of State (quoting Ref. TNW 5164/41/39/01), at his address at the office of the Department of Transport, Government Office-North West, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE, object to the making of the Order.

#### **HIGHWAYS ACT 1980**

#### The County Council of Northumberland (Duplicate Kitty Brewster Bridge) Scheme 1994

The Secretary of State for Transport hereby gives notice that he had confirmed without modification the above scheme which was made by the county Council of Northumberland under section 106(3) of the Highways Act 1980 and which, as confirmed, authorises the Council to construct as part of the construction and improvement of the A189 between Bebside in the District of Blyth Valley, and Bedlington Station in the District of Wansbeck, a bridge over the navigable waters of the River Blyth.

Copies of the scheme (as confirmed) and of the relevant plans and specifications may be inspected, free of charge, at all reasonable hours at the offices of the Northumberland County Council, County Hall, Morpeth, Northumberland NE61 2EF.

Copies of the Instrument of Confirmation of the Scheme, which is entitled "The County Council of Northumberland (Duplicate Kitty Brewster Bridge) Scheme 1994 Confirmation Instrument 1994" and which contains a copy of the scheme as confirmed, can be purchased, price £2.40, SI No. 2170, either through booksellers or direct from government bookshops (HMSO).

Any person aggrieved by the scheme and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act, or any regulations made thereunder, has not been complied with in relation to the scheme. may, within 6 weeks from 6th September 1994, apply to the High Court for the suspension or quashing of the Scheme or any provisions contained therein.
