CONSUMER PROTECTION ACT 1987, PART II

General Safety Requirement (The Approval of Safety Standards Regulations 1987) (SI 1987/1911); Regulations 2 and 3

Notice No. 13—Cancellations

The Secretary of State has cancelled the approval (previously made for the purpose of section 10(3) of the Consumer Protection Act 1987) of the standards mentioned below.

The cancellation takes effect from 2nd August 1994. This Notice effectively cancels all existing approvals. It also marks the end of the system of approved standards under the 1987 Act.

The forthcoming General Product Safety Regulations will implement the provisions of the European Directive on general product safety. These Regulations will also revoke the Approval of Safety Standards Regulations 1987, and repeal section 10(3)(ii) of the 1987 Act, which provided the legal power for Ministers to approve standards, and cancel approvals.
