The Secretary of State for Transport hereby gives notice that he proposes to make the following three Orders under section 247 of the above Act.

If the Orders are made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Franklin Stafford Partnership by the London Borough of Hackney on 5th November 1993 under reference TP/80881/C/TF/HS.

First Order (ref. LRO 34/U5360/1/0/011), to authorise the stopping-up of a length of Long Street, London E.C.2, east of viaduct arch 403.

Second Order (ref. LRO 34/U5360/1/013), to authorise the stopping-up of a length of Long Street, London E.C.2, west of viaduct arch 403 and the whole of the unnamed footpath through viaduct arch 403.

Third Order (ref. LRO 34/U5360/1/014), to authorise the stopping-up of a length of Union Walk, and an adjoining triangular shaped part of Long Street, London E.C.2.

Copies of the draft Orders and relevant plans may be inspected at all reasonable hours during 28 days commencing on 9th September 1994 at the offices of the London Borough of Hackney, Joseph Priestly House, 73 Morning Lane, London E.9 and may be obtained free of charge from the London Policy and Traffic Management Division (quoting references LRO 34/U5360/1/0/011), LRO 34/U5360/1/013 and LRO 34/U5360/1/014) at the address stated below.

Any person may object to the making of the proposed Orders within the period of 28 days commencing on 9th September 1994 by notice to the Secretary of State for Transport, quoting the above references, at the London Policy and Traffic Management Division, Government Office for London, Room C8/04, 2 Marsham Street, London SW1P 3EB.

In preparing an objection it should be borne in mind that the substance of it may be imparted to other persons who may be affected by it and that those persons may wish to communicate with the objector about it.
