#### TOWN AND COUNTRY PLANNING ACT 1990

Stopping-up of Highways at Kearsley, Bolton

The Secretary of State for Transport hereby gives notice that on the application of Bolton Metropolitan Borough Council he has made an Order under section 247 of the above Act entitled "The Stoppingup of Highways (Metropolitan Borough of Bolton) (No. 3) Order 1994" authorising the stopping-up of Thomas Street and a part of George Street at Kearsley in the Metropolitan Borough of Bolton and requiring the provision of a new highway which will be a footpath along the full length of Thomas Street.

#### TOWN AND COUNTRY PLANNING ACT 1990

#### Proposed Stopping-up of a Highway at Macclesfield

The Secretary of State for Transport hereby gives notice that on the application of Pochin (Design & Build) Ltd., he proposes to make an Order under section 247 of the above Act which will authorise the stopping-up of a length of Riseley's Passage at Macclesfield, from its intersection with King Edward Street and extending southwards for a distance of approximately 28 metres.
