#### MID GLAMORGAN COUNTY COUNCIL

*Mid Glamorgan County Council (Felindre Road and Coychurch Road, Pencoed) (Revocation) and (Prohibition of Waiting) Order 1994.*

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1, 2 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the effect of which will be to:

- (i) revoke the provisions of the "Mid Glamorgan County Council (Coychurch Road/Felindre Road, Pencoed) (Prohibition of Waiting Order) 1990";
- (ii) prohibit the waiting of vehicles at any time on the length of road and sides of length of road specified in the Schedule to this notice.

#### MID GLAMORGAN COUNTY COUNCIL

*Mid Glamorgan County Council (Penyfa Road, Aberkenfig) (Prohibition of Entry) (Except Buses and Coaches) Order 1994*

Notice is hereby given that on 26th September 1994, the Mid Glamorgan County Council made an Order under sections 1, 2 and 3 of the Road Traffic Regulation Act 1984, the effect of which is to prohibit any vehicle from entering the length of road specified in the Schedule to this notice.

#### MID GLAMORGAN COUNTY COUNCIL
