

## LONDON BOROUGH OF HARINGEY

*The Haringey (Bus Lane) (No. 1) Traffic Order 1994*

Notice is hereby given that the Council of the London Borough of Haringey proposes to make the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1984.

The general effect of the Order will be to prohibit any vehicle (subject to exceptions) from driving in a bus lane in Turnpike Lane, London N.8. lying on the north side between a point 35 metres north-east of the north-eastern kerb-line of Hornsey Park Road and a point 10 metres south-west of the south-western kerb-line of Waldegrave Road.

The above-mentioned requirements would not apply to anything done:

- (a) To avoid an accident or to comply with the Law;
- (b) With the permission or at the direction of a police constable in uniform;
- (c) In accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

*The Haringey (Doctor Parking Places) (No. 3) (Amendment No. 2) Traffic Order 1994*

Notice is hereby given that the Council of the London Borough of Haringey on 29th September 1994, made The Haringey (Doctor Parking Places) (Special Parking Area) (No. 3) (Amendment No. 2) Traffic Order 1994, under sections 45, 46 and 49 of the Road Traffic Regulations Act 1984.

2. The general effect of the Order will be to:

- (a) Designate one extra doctor parking place in West Green Road, London N.15.
- (b) Provided that:
  - (i) only vehicles displaying permits issued under the Order may be left in the parking place during the operative hours;
  - (ii) the parking places will be in operation between 8 a.m. to 8 p.m. on any one day of the week;
  - (iii) a permit may be issued by the Haringey Borough Council on application being made by a qualified medical practitioner;
  - (iv) the charge in connection with the issue of permits for the use of the parking place will be £45 per parking place and that the permits will be valid for a period of 12 months.

3. The requirements mentioned in 2(a) and (b) above would not apply to anything done:

- (a) with the permission or at the direction of a police constable in uniform;
- (b) in accordance with any restrictions or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

*The Haringey (Prescribed Routes) (No. 2) Traffic Order 1994*

## LONDON BOROUGH OF HARINGEY

*The Haringey (Waiting and Loading Restriction) (Amendment No. ) Order 1994*

Notice is hereby given that the Council of the London Borough of Haringey proposes to make the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1984.

The general effect of the Order would be to impose longer waiting and loading restrictions in Turnpike Lane, N.8.

The prohibitions referred to in the above paragraph do not apply in respect of anything done with the permission or at the direction of a Police Constable in uniform or in certain circumstances e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol from road side petrol stations; to licensed street traders etc. The usual exemption relating to vehicles displaying a disabled persons' "Orange Badge" does apply.
