Disabled Persons' Parking Places

Notice is hereby given that the Islington Borough Council proposes to make the Islington (Free Parking Places) (Disabled Persons) (No. 5) Order 1994, under section 6 of the Road Traffic Regulation Act 1984.

The general effect of the Order will be to:

- (a) designate parking places in Barnsbury Road, Beversbrook Road, Calabria Road, Canonbury Villas, Milner Square, Playford Road, Riversdale Road and Trinder Road;
- (b) provide that the parking places will operate between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (c) specify, in respect of the parking places, that a disabled person's vehicle displaying, in the relevant position, a disabled person's badge (commonly referred to as "the Orange Badge") issued by any Local Authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982 may be left therein; and
- (d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.

A copy of the Order, of the Islington (Free Parking Places) (Disabled Persons) (No. 1) Order 1980, (and of the Orders which have amended or applied that Order) and of the Council's statement of reasons for making the Order, and of maps which indicate the lengths of roads to which the Order relates can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date of this notice at the following location:

Islington (Prescribed Routes) (Amendment No. 107) Order 1994, and the

Islington (Prescribed Routes) (No. 110) Traffic Management Order 1994

Both relating to the Wilmington Square Area

Notice is hereby given that the Islington Borough Council proposes to make the above-mentioned Orders under section 6 of the Road Traffic Regulation Act 1984.

2. The general effects of the Orders will be to:

- (a) Prohibit any vehicle from entering or exiting from Wilmington Square at its junction with Merlin Street and Wilmington Street.
- (b) Prohibit any vehicle from entering or exiting from Yardley Street at its junction with Margery Street.
- (c) Prohibit any vehicle from proceeding in Wilmington Street, between its junctions with both Margery Street and Merlin Street, other than in a southbound direction.

3. Nothing in these Orders shall apply:

- (a) in relation to a vehicle being used for ambulance, fire brigade or police purposes in an emergency;

- (b) to anything done with the permission or at the direction of a police constable in uniform;

- (c) to any person who causes any vehicle to proceed in any road in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984.

4. A copy of the Orders (and plans indicating details of the measures referred to in paragraph 2 above) and of the Council's statement of reasons for making the Orders can be inspected until the expiration of a period of 21 days from the date of this notice at the following location, during normal office hours on Mondays to Fridays inclusive:

LONDON BOROUGH OF LEWISHAM

The Lewisham (Prescribed Routes) (No.) Traffic Order 1994

Notice is hereby given that the Council of the London Borough of Lewisham, in accordance with the provisions of section 6 of the Road Traffic Regulation Act 1984 as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985, propose to make the above-mentioned Traffic Order.

2. The effect of the Order would be to:

- (a) Prohibit any vehicle (other than the emergency services) from entering or proceeding in Deptford High Street between the junction with Deptford Broadway and New Cross Road and the junction with Giffin Street on Fridays between the hours of 6 a.m. and 7.30 p.m. (in order to enable the operation of a regular Friday street market);
- (b) Extend the hours of operation of the existing prohibition/closure (for the existing street market) from between 6 a.m. and 4.30 p.m. on Wednesdays and from between 7 a.m. and 7 p.m. on Saturdays to between the hours of 6 a.m. and 7.30 p.m. on all market days.

3. This would be done by revoking The Lewisham (Prescribed Routes) (No. 1) Traffic Order 1977 [G.L.C. 1977/No. 222] and The Lewisham (Prescribed Routes) (No. 3) Traffic Order 1987 [L.B.L. 1987/No. 19] and consolidating and reintroducing their provisions to include the new provisions and amendments at 2(a) and (b) above in a single Traffic Order.

4. Exemption would be provided for in the Order for:

- (a) vehicles being used in pursuance of statutory duties of a local authority;
- (b) vehicles proceeding in accordance with any requirement indicated by traffic signs placed on the highway on behalf of the Metropolitan Police;
- (c) fire authority, ambulance or police vehicles in an emergency;
- (d) anything done with the permission or at the direction of a police constable in uniform.

5.
