COAST PROTECTION ACT 1949

Notice is hereby given that Canterbury City Council, acting in its capacity as Coast Protection Authority, hereby gives notice under sub-section (1) of section 5 of the above Act, that it proposes to carry out Coast Protection works at Preston Parade, Seasalter and Admiralty Walk, Whitstable, Kent.

The works will consist of the importation of approximately 8,000 cubic metres of graded beach material, 4,000 at Preston Parade and 4,000 at Admiralty Walk, placing it on the foreshore and grading it to the required profile.

The estimated cost of the works, inclusive of salaries of technical staff and other costs, is £131,500.
