The A487 Trunk Road (Caernarfon, Gwynedd) (Restricted Roads and 40 m.p.h. Speed Limit) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 82, 83, 84 and 124 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to impose a 30 m.p.h. speed limit on the lengths of the A487 Trunk Road (hereinafter referred to as "the trunk road") specified in Schedule 1 to this notice and a 40 m.p.h. speed limit on the length of the trunk road specified in Schedule 2. The Trunk Road (Caernarfon Gwynedd) (Restricted Roads and 40 m.p.h. Speed Limit) Order 1981, the provisions of which will be revoked and re-enacted, amended as necessary by the proposed Order, currently imposes a 40 m.p.h. speed limit on the trunk road in this area.

During a period of 21 days from 7th October 1994 a copy of the proposed Order, the Order being revoked, together with a plan and the statement of reasons for making the proposed Order may be inspected during normal office hours at the offices of Gwynedd County Council County Offices, Caernarfon, Gwynedd.

3. The northbound entry slip road which connects the Poolside-Llanberis Road Roundabout to the trunk road.

4. The southbound exit slip road which connects the trunk road to the Poolside-Llanberis Road Roundabout.

5. The southbound entry slip road which connects the Poolside-Llanberis Road Roundabout to the trunk road.
