Notice is hereby given in accordance with Schedule 10 of the above Act that an application has been made to the National Rivers Authority by The Stoneleigh Abbey Preservation Trust for consent to discharge the following volumes of treated sewage effluent to the River Avon as detailed in the following table:

Application reference CPV/LS/60007 will replace an existing discharge from the site which is currently consented to discharge up to 28 cubic metres per day of treated sewage effluent. Should this application be granted the existing consent will be revoked. Notice of application for a licence to abstract water

Take notice that L. W. Butcher & Sons, Middle Fen Farm, Earith Road, Willingham, Cambridgeshire CB4 5LT, are applying to the National Rivers Authority for a licence to abstract water from the River Great Ouse (Old West) between National Grid References TL 4107/7334 and TL 4177/7292; the Shoalmill Drain between National Grid References TL 4208/7240 and TL 4214/7215; together with main drains and farm dykes adjoining land in our occupation at Middle Fen Farm and Flat Road, Willingham; all in the parish of Willingham, in the district of South Cambridgeshire, in the county of Cambridgeshire.

The proposal is to abstract water at the following rates: 45.5 cubic metres per hour, 682.5 cubic metres per day, 13,637 cubic metres per year between April and October each year. The water will be used for spray irrigation purposes. This is a renewal application for a licence to replace licence No. 6/33/35/226/9 which expires 30th September 1994. There are increases in the hourly and daily abstraction rates, but a reduction in the period quantity abstracted. There are additional parcels of land and abstraction points, and the period of abstraction extended.
