# **ROAD TRAFFIC ACTS**

## MID GLAMORGAN COUNTY COUNCIL

Mid Glamorgan County Council (Napier Street (Part) and Ivor Street, Mountain Ash) (One-Way Traffic) Order 1994

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit any person, except upon the direction or with the permission of a Police Constable in uniform, from causing any vehicle to proceed in the road and length of road specified in column 1 of the Schedule to this notice in a direction other than that specified in relation to the road and length of road in Column 2 of the Schedule to this notice.
