- (i) *B3048 Stoke Lane* between a point 153 metres south-east of its junction with Stoke Hill and a point 848 metres north-east of that point.
- (ii) *Stoke Hill* between its junction with Stoke Lane and a point 173 metres south-west.
- (iii) *Chapel Lane* between its junction with Stoke Lane and a point 131 metres north-west.
- (iv) *The unclassified Stoke-Sladen Green Road* between its junction with Stoke Lane and a point 410 metres north-east.
