## A PROCLAMATION,

Requiring the Attendance of the Members of both Houses of Parliament.

GEORGE R.

Whereas the two Houses of our Parliament stand Adjourned unto Wednesday the Fourteenth Day of December next ensuing; We, with the Advice of Our Privy Council, do hereby Publish and Declare Our Pleasure, That the said Parliament shall on the said Fourteenth Day of December next, be Held and sit for the Dispatch of divers Weighty and Important Affairs. And the Lords Spiritual and Temporal, and the Knights, Citizens and Burghesses, and Commissioners for Shires and Burghs of the House of Commons, are hereby Required and Comanded to Give their Attendance accordingly at Westminster on the said Fourteenth Day of December next.

Given at Our Court at St. James's, the Twenty second Day of November, 1715. And in the Second Year of Our Reign.

St. James's, November 25. The following Addresses has been presented to His Majesty
