(e) If coliform organisms detected in any sample, follow instructions given in sections 7.7 to 7.11 of "Guidance on Safeguarding the Quality of Public Water Supplies" as appropriate. To be completed as soon as analytical results become available and not more than 30 hours after the time of sampling.
