

SCHEDULE 2

(No Waiting at Any Time)

1. The south-eastern side of that length of the trunk road known as Priory Street which extends from a point 15 metres south-west of the centrepoint of its junction with Furnace Bank in a north-easterly direction to a point 15 metres north-east of the centrepoint of that junction.

2. The south-eastern side of that length of the trunk road known as Abbey Mead which extends from a point 55 metres north-east of the centrepoint of its junction with Furnace Bank in a north-easterly direction for a distance of 13 metres.

SCHEDULE 3

(Waiting Restriction/Prohibition Removed)

1. The south-eastern side of that length of the trunk road known as Priory Street which extends from a point 15 metres north-east of the centrepoint of its junction with Furnace Bank in a north-easterly direction to a point 55 metres north-east of the centrepoint of that junction.

2. The south-eastern side of that length of the trunk road known as Abbey Mead which extends from a point 68 metres north-east of the centrepoint of its junction with Furnace Bank in a north-easterly direction to a point 137 metres north-east of the centrepoint of that junction. (482)
