Kingston-upon-Hull, New Cleveland Street (Temporary One-way Traffic) Order 1994

Notice is hereby given that the Kingston-upon-Hull City Council by virtue of section 101 of the Local Government Act 1972 and section 14(1) of the Road Traffic Regulation Act 1984, intends to make an Order.

The effect of the Order will be to direct any person with (or without) a vehicle how they may proceed along New Cleveland Street (from its junction with Witham to Spyvee Street) on the following days:

Sunday, 18th December 1994—all vehicles will travel from south to north i.e. north bound. The alternative route is via New Cleveland Street, Spyvee Street and Lime Street.

Sunday, 8th January 1995—all vehicles will travel from north to south i.e. south bound. The alternative route is via Lime Street, Spyvee Street and New Cleveland Street.
