NOTICE OF PROPOSED PUBLIC PATH DIVERSION ORDER TOWN AND COUNTRY PLANNING ACT 1990

(Public Footpaths E.B.W.2 (Part) and E.H.U. 23 (Part))

Notice is hereby given that the Secretary of State for the Environment, in exercise of the powers conferred on him by section 247 and section 253 of the Town and Country Planning Act 1990, and all other powers enabling him in that behalf, proposes to make an Order the effect of which will be:

To divert the part of public footpath E.B.W.2 which runs between a point (marked A on the Order Map) 300 metres south-east of the M5 Motorway Embankment toe and a point (marked B on the Order Map) 80 metres further south-east, to a line looping south for approximately 100 metres from the said point A, via point X, and returning to point B.

To divert the part of public footpath E.H.U.23 which runs between a point (marked C on the Order Map) 335 metres south-east of the M5 Motorway Embankment toe and a point (marked D on the Order Map) 65 metres further south-east, to
