### ROAD TRAFFIC REGULATION ACT 1984—SECTION 9

The A4 Trunk Road (Hillingdon) (Prescribed Routes) Experimental Traffic Order 1995

The Secretary of State for Transport hereby gives notice that on 8th February 1995, he made the above-named Order, the effect of which is to open to traffic the northern sector of the roundabout at the southern extremity of the M4 Heathrow Airport Spur and impose one-way traffic eastbound on the Excelsior slip road.

Under the provisons of section 9 of the Road Traffic Regulation Act 1984, the Order may continue in force for a period not exceeding 18 months from the date it comes into force.
