##### *Declaration of National Nature Reserve in the Parishes of Chobham and Sunningdale in the Counties of Surrey and Berkshire*

Notice is hereby given, in pursuance of section 19 of the National Parks and Access to the Countryside Act 1949 and section 35 of the Wildlife and Countryside Act 1981, that by the National Nature Reserve No. 1 Declaration 1995 made on the 23rd day of March 1995, the Nature Conservancy Council for England declared that the land containing 516.5 hectares or thereabouts situated in the Parishes of Chobham and Sunningdale in the Counties of Surrey and Berkshire and shown shaded grey on the plan attached to the said Declaration, is being held by the Surrey County Council a body approved by the Council and is being managed as a nature reserve.
