TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Nantyffyllon Maesteg, Mid Glamorgan) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in the Schedule to this notice.

The Order requires the provision of a new footpath which will be a highway maintainable at public expense, for which Mid Glamorgan County Council shall be the Highway Authority.

If the Order is made, the stopping-up will be authorised only in order to enable residential development to be carried out in accordance with planning permission granted to Hafod Housing Association Ltd by Ogwr Borough Council on 17th February 1994, under reference P/93/1281/FUL.

During the 28 days from 24th March 1995 copies of the draft Order and the annexed plan may be inspected during normal office hours at the offices of Maesteg Community Council, Council Offices, Talbot Street, Maesteg, Mid Glamorgan or may be obtained, free of charge, from the address, and quoting the reference, below.

Within the above mentioned period of 28 days any person may, by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting reference ZC 510-5-5-43), object to the making of the Order. In the preparation of an objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

The Highways to be stopped-up are at Nantyffyllon in the county of Mid Glamorgan and comprise:

1. the entire length of un-named highway which forms a west-east path linking Tonna Road to Glanavon Terrace.
2. a 225 millimetres wide strip of the un-named highway running north-south between Glanavon Terrace and Tonna Road, located approximately 30.9 metres from the centreline of its junction with Bedw Street and which extends from its eastern side for a distance of approximately 3.3 metres in a westerly direction. The A5 Trunk Road (Various Roads, Corwen, Clwyd) (Restriction of Waiting) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2, 4 and 124 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to:

- (a) impose an all year round waiting restriction on the length of the A5 London-Holyhead Trunk Road (hereinafter referred to as "the trunk road") described in Schedule 1 to this notice (waiting is currently prohibited on this length of the trunk road
