(Prohibition and Restriction of Waiting) Order 1995*

## CLWYD COUNTY COUNCIL

*The County Council of Clwyd (B5430 Liver Inn/Graianrhyd)  
(Weight Restriction) Order*

Notice is hereby given that the Clwyd County Council propose to make an Order under sections 1(1) and (2) and 2(1) to (3) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit any heavy commercial vehicle (namely any goods vehicle which has an operating weight exceeding 7.5 tonnes as defined in section 138 of the Road Traffic Regulation Act 1984) from proceeding in the lengths of road specified in the Schedule to this notice.
