

NEW ROADS AND STREET WORKS ACT

HERTFORDSHIRE COUNTY COUNCIL

NEW ROADS AND STREET WORKS ACT 1991, SECTION 58

Notice of Substantial Roadworks

Three months notice is hereby given that Hertfordshire County Council's Transportation Design Services intends to carry out the substantial roadworks at the locations specified in the Schedule below.

2. The Street/Road in which these works will take place is specified in the said Schedule.

3. The work is expected to affect the carriageway/footway/footpath/verge as specified in the said Schedule.

4. The work is expected to commence on the corresponding dates specified in the said Schedule.

5. The area and extent of the works notified are specified in the Schedule.

6. Subject to the exceptions in the Act and Regulations under it, no street works may be executed for a period of 12 months from completion of the works described in paragraph 5 without the consent of Hertfordshire County Council Transportation Design Services which shall not be unreasonably withheld.

- (ii) *Whitehall Road, Hitchin*: A length of carriageway between Passingham Avenue and Hollow Lane. To be commenced and undertaken during July 1995.
- (iii) *William Road, Hitchin*: A length of carriageway between A505 Cambridge Road and Purwell Lane. To be commenced and undertaken during July 1995.
- (iv) *Old Hale Way, Hitchin*: A length of carriageway between the junction of Brand Street and the junction of Hermitage Road. To be commenced and undertaken during July 1995.
- (v) *Wilbury Road, Letchworth*: A length of carriageway between Grange Road and Bedford Road. To be commenced and undertaken during July 1995.
- (vi) *Bancroft, Hitchin*: A length of carriageway between the junction of Brand Street and the junction of Hermitage Road. To be commenced and undertaken during July 1995.
- (vii) *Mons Avenue, Baldock*: A length of carriageway in Mons Avenue. To be commenced and undertaken during July 1995.
- (viii) *Radcliffe Road, Hitchin*: A length of carriageway between Nightingale Road and Walsworth Road. To be commenced and undertaken during July 1995.
- (ix) *Dacre Road, Hitchin*: A length of carriageway between Nightingale Road and Walsworth Road. To be commenced and undertaken during July 1995.
- (x) *Kite Way, Letchworth*: A length of carriageway between Wilbury Road and Linnet Close. To be commenced and undertaken during July 1995.
- (xi) *Wilbury Hills Road, Letchworth*: A length of carriageway between Bedford Road and Icknield Way.
- (xii) *Old North Road, Royston*: A length of Footway between the Railway Bridge and Rock Road. To be commenced and undertaken during July 1995.
- (xiii) *Kyrkeby Letchworth*: The entire length of Footway. To be commenced and undertaken during July 1995.
- (xiv) *Broadway, Letchworth*: A length of Footway in the Broadway. To be commenced and undertaken in July 1995.

Stopping-up of a Highway

Proposed Traffic Calming Measures—Bush Road, Cuxton

Notice is hereby given that, the Council proposes in accordance with section 90(A)–(I) of the Highways Act 1980 and all other enabling powers to install the following traffic calming measures in Bush Road, Cuxton:

- Road hump located 42 metres west of its junction with Sundridge Hill (outside No. 1) Table junction located at its junction with May Street (outside Nos. 46/48).
 - Road Hump located 29 metres north-west of its junction with Wood Street (outside No. 70).
 - Road Hump located 183 metres south-east of its junction with Charles Drive (outside No. 131/133).
 - Road Hump located 47 metres south-east of its junction with Charles Drive (outside Nos. 161/163).
- (Note: dimensions are taken from the centre of the adjoining carriageway to the centre of the proposed road hump).

It is also proposed that the traffic priorities be altered at the junction of Bush Road and Charles Drive.

The proposals are required to increase public safety on the highway by reducing traffic speed in Bush Road, Cuxton.

A map containing full details and a statement of the Council's reasons for implementing the proposal may be examined at the Civic Centre, Strood, during normal office hours.
