HIGHWAYS ACT 1980 — SECTION 116

Notice is hereby given that the Surrey County Council as Highway Authority intend to apply to the Godstone Magistrates' Court sitting at The Police Station, East Hill Road, Oxted in the county of Surrey on Thursday, 27th April 1995, at 11 a.m. for Orders pursuant to section 116 of the Highways Act 1980 that the areas of highway land referred to below subject to public vehicular use shall be stopped up on the grounds that they are unnecessary for public vehicular use and that the areas of highway referred to below subject to public rights of way on horse and on foot be diverted to make them more commodious to the public. THE LAKE DISTRICT SPECIAL PLANNING BOARD

The Lake District Special Planning Board (Whitbarrow & Yewbarrow) Limestone Pavement Order 1995

Notice is hereby given that on Monday, 20th March 1995, the Lake District Special Planning Board made the above-named Order designating the land described in the Order as a limestone pavement under section 34 of the Wildlife and Countryside Act 1981.

The Order took effect when it was made and shall cease to have effect 9 months after that date unless the Secretary of State for the Environment has previously given notice under paragraph 6 of Schedule II of the Act that he has considered it and does not propose to amend or revoke it or he has amended or revoked it or the Board has itself revoked it.

The effect of the Order is to prohibit the removal or disturbance of limestone on or in the land designated in the Order. If any person without reasonable excuse removes or disturbs limestone on or in the land so designated he shall be liable to a fine as specified in section 34(4) of the Act.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Witherslack and Crosthwaite Post Offices, and at the National Park Offices, Murley Moss, Oxenholme Road, Kendal, Cumbria, at all reasonable hours.
