TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (County of Durham) (No. 3) Order 1995" authorising the stopping-up of part of the highway adjacent to the Employment Services Office, Front Street, Stanley, to enable the development described in the Schedule to this notice to be carried out in accordance with planning permission granted to Rooker Stringer & Jones, on behalf of Stratford Properties Teeside Ltd., by Derwentside District Council, on 10th May, under Ref. 1/93/333/DM.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 4th April 1995, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
