ROAD TRAFFIC ACTS

DEVON COUNTY COUNCIL

The County of Devon (Various Streets, Brixham) (Control of Waiting, Loading and Unloading) Order

Notice is hereby given that the Devon County Council propose to make the above Order under the provisions of the Road Traffic Regulation Act 1984 the effect of which will be to:

1. Prohibit waiting at any time in the following length of road in Brixham:

- Heath Park, west side, from its junction with Heath Road southwards for a distance of 10 metres;
- 2. Revoke the prohibition of waiting at any time in the following length of road in Brixham:

Barnfield Road, east side, whole length; and

3. Consolidate the existing waiting restrictions in Brixham into one Order.

The proposed Order will contain the usual exemptions relating to the picking-up and setting down of passengers, loading and unloading of goods, disabled persons' vehicles, the maintenance of the road and telecommunications apparatus, and the supply of gas, water and electricity.

Full details of the proposals are contained in the draft Order which, together with a plan illustrating the proposals and a statement of the Council's reasons for proposing to make the Order, may be inspected during usual office hours at the offices of Torbay Borough Council, Town Hall, Torquay; and at the Town Hall, Brixham.
