Notice is hereby given in accordance with Schedule 10 of the above Act, that an application has been made to the National Rivers Authority by British Waterways for consent to discharge up to 32,000 cubic metres per day of sludge consisting of canal dredgings from the Gloucester-Sharpness canal to the tidal reaches of the River Severn from Purton Lower Bridge, Purton, Gloucestershire, at National Grid Ref. SO6862 0436. This application relates to existing procedures which are currently unconsented and should consent be granted by the Authority it will authorise the existing situation and enable the discharge to be brought under control.

Notice of application for a licence to abstract water and to vary an existing licence

Take notice that Marshall Farms of Barracks Farm, Papplewick, Nottingham are applying to the National Rivers Authority for licences to abstract water details of which are as follows:

1. New licence to abstract 1,130 cubic metres per day, 30,000 cubic metres per year, from the River Leen, at NGR SK 54515125, at Papplewick.
2. Vary Licence No. 3/28/63/76/S to abstract from a tributary of the River Leen, at NGR SK 55255028, to increase annual abstraction from 13,638 cubic metres to 60,000 cubic metres and to increase the area of land to be irrigated.

The water will be used for spray irrigation purposes during the months of April to October inclusive.

Notice of application for consent for the purposes of section 88

Notice is hereby given in accordance with Schedule 10 of the above Act, that an application has been made to the National Rivers Authority by Severn Trent Water Limited, for consent to discharge up to 259,200 cubic metres per day of sewage only in an emergency (138,000 cubic metres per day under dry weather conditions), and a rainfall dependent volume of storm sewage consisting of flows in excess of 7,465 litres per second (flows upto this figure will continue to be passed in to Wanlip Sewage Works for treatment), to the River Soar, at National Grid Ref. SK 5963 1195, from Wanlip (new) Sewage Pumping Station, Fillingate, Wanlip, Leicestershire. The pumping station is to be fitted with the following facilities to prevent a discharge of sewage in an emergency in all but the most exceptional of circumstances:

1. Standby pumping (automatic start up);
2. Telemetry alarm to a 24 hour manned control room;
3. Dual electricity supply; and

4. Large storage volume (30,000 cubic metres = 5 hours at the dry weather flow rate). This volume will also have to be fully utilised before any storm sewage discharge occurs. In addition the overflow outlet will be designed to limit the discharge of gross solids.
