WILDLIFE AND COUNTRYSIDE ACT 1981: SECTION 29

Whetley Meadows (Dorset) Nature Conservation Order 1994

Notice is hereby given under paragraph 6 of Schedule 11 to the Wildlife and Countryside Act 1981, that the Secretary of State has considered the above-named unopposed Order and does not propose to amend or revoke it. In consequence the Order which took effect on 1st July 1994, will continue in effect.

The general effect of the Order is to impose restrictions on the carrying out of certain operations specified in the Order on land described in the Order (which is an area of some 6.88 hectares of land situated within the Whetley Meadows SSSI, Dorset, the exact delineation of which is set out on the plan referred to in the Order).

Copies of the Order and map referred to in it and of this notice have been deposited at the offices of the West Dorset District Council, 58-60 High West Street, Dorchester, Dorset DT1 1UZ. They may be seen, free of charge, at all reasonable hours.

Any person who is aggrieved by the Order and desires to question it validity on the grounds that it is not within the powers of section 29 of the said Act of 1981, or that any of the requirements of Schedule 11 to that Act had not been complied with in relation to it may within 6 weeks from the date of this notice make an application to the High Court under paragraph 7 of the said Schedule (Ref. No. LG2/01/EWD.)

NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1990

The Wakefield (South Hiendley Public Paths Nos. 15 and 16) Temporary Diversion Order 1995

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred on him by sections 247, 253 and 261 of the Town and Country Planning Act 1990 and all other powers enabling him in that behalf, proposes to make an Order if planning permission is granted by him for development to be carried out consisting of the extraction of coal and clay by opencast methods and subsequent development of land as a golf course on land off Brierley Road, South Hiendley.

The effect of the Order will be to divert for a period of 2 years footpath No. 15 for 185 metres (from point A to C) and footpath No. 16 for 105 metres (from D to B) on land off Brierley Road, South Hiendley. The lines and situation of the existing and proposed alternative highway are shown on the map annexed to the draft Order.

The proposed Order will require restoration of the diverted length of footpath at the end of the said period.

A copy of the draft Order and the map annexed to it has been deposited at the offices of the Wakefield Metropolitan District Council, Chantry House, 123 Kirkgate, Wakefield WF1 1YG, and may be inspected, free of charge, at all reasonable hours, during a period of 28 days from 6th April 1995.
