- (3) Outer Circle, western end of southern loop, both sides from its junction with Roman Road south-westward to the common boundary of No. 1 Outer Circle/98 Roman Road.
- (4) Outer Circle, western end of northern loop, western side, from its junction with Roman Road south-eastward for a distance of approximately 15 metres. Eastern side, from its junction with Roman Road north-westward for a distance of approximately eight metres.
