#### LIGHT RAILWAYS ACT 1896

The Secretary of State for Transport, in exercise of his powers under the Light Railways Act 1896, as amended by the Light Railways Act 1912 and Part V of the Railways Act 1921 and now vested in him, made the Foxfield Light Railway Order on 3rd May 1995. The Order places on a statutory footing the operation and maintenance of a 3-mile leisure railway on a former industrial line between Foxfield Wood and Forsbrook in Staffordshire and authorises the construction and operation of a 250 metre extension of the railway within the site of the former Foxfield Colliery.
