

KENT COUNTY COUNCIL

*The Kent County Council (Rochester Grand Prix)
(Temporary Restrictions) Order 1995*

Notice is hereby given that the Kent County Council in exercise of its powers contained in section 16(A) of the Road Traffic Regulation Act 1984 ("the Act") inserted by the Road Traffic Regulation (Special Events) Act 1994, and of all other enabling powers, and with the consent of the Secretary of State for Transport given under section 16A(6) of the Act, intends after at least 21 days, to make an Order which:

(a) will prohibit vehicles proceeding in the following roads in Rochester between 1700 and 2130 hours on Wednesday, 14th June 1995:

Archdeaconry Road.
Bakers Walk.
Boley Hill.
Castle Hill.
Corporation Street (westbound carriageway, between Northgate and Esplanade).
Epaule Lane.
Esplanade (between Corporation Street and Hathaway Court).
High Street (between Northgate and Corporation Street).
Minor Canon Row.
Rochester Bridge (Old Bridge, between Esplanade, Rochester and Esplanade, Strood).
St. Margaret's Street (between The Precinct and Boley Hill).
The Precinct.

The alternative route for westbound traffic in the section of Corporation Street between Northgate and Esplanade, and the section of Rochester Bridge (Old Bridge) between Esplanade, Rochester and Esplanade, Strood, will be via a contra-flow arrangement on the eastbound carriageway.

The alternative route for through traffic will be via Maidstone Road, East Row, Victoria Street, Star Hill and Corporation Street, and vice versa.

(b) will prohibit vehicles turning right between 1700 and 2130 hours on Wednesday, 14th June 1995:

- (i) from Canal Road, Strood into High Street/Rochester Bridge (westbound);
- (ii) from the High Street/Rochester Bridge (westbound), Strood into Canal Road;
- (iii) from Esplanade, Strood into High Street/Rochester Bridge (eastbound);
- (iv) from High Street/Rochester Bridge, Strood (eastbound) into Esplanade;
- (v) from Gas House Road, Rochester into Corporation Street (westbound);
- (vi) from Corporation Street, Rochester (westbound) into Gas House Road;
- (vii) from Corporation Street, Rochester (eastbound) into Northgate.

The alternative route for vehicles affected by the prohibited turns are via Rochester Bridge, Corporation Street, Bardell Terrace, Furrells Road and High Street, Rochester, and via High Street, and Commercial Road, Strood.

The Order is required to provide for the safety of road users during a cycle race known as "The Rochester Grand Prix".

The Order, a map containing full details, and a statement of the Council's reason for making the Order may be examined at these offices during normal office hours.

*The Portsmouth (Sundridge Close) (Prohibition of Right Turn)
(No. 31) Order 1995*
