

The general effect of the Disabled Person's Permit Parking Places Order would be to provide a disabled persons' permit parking place in Pollitt Drive which would be available for the use of vehicles which display a Westminster disabled permit issued in respect of that parking place without charge or time limit.

The general effect of the Doctor Parking Place would be to revoke redundant doctor parking spaces in Norfolk Place and St. Michael's Street.

- (a) extend residents' parking place in St. Michael's Street;
- (b) remove a certain length of residents' parking in Pollitt Street;
- (c) provide a 2-hour metered parking place in Norfolk Place;
- (d) provide that in the residents' parking place, vehicles displaying a valid parking card bearing the letter "B" issued by the City Council in respect of that vehicle may be left. The charge for their use would be 70 pence per day unless a valid season ticket is displayed. Season ticket cost £20 for 3 months or £71 for 12 months;
- (e) to provide that in the 2-hour metered parking place the parking charge will be at the rate of 50 pence for 20 minutes (maximum parking period 2 hours), any unexpired time shown on a parking meter may be used free of charge and the period during which a vehicle may not return to the parking place will be 1 hour;
- (f) to provide that in the 2-hour metered parking place the vehicles which may be left therein shall be passenger vehicles (12 seats or less), certain goods carrying vehicles, motorcycles and invalid carriages;
- (g) to provide that the hours of operation will be between 8.30 a.m. and 6.30 p.m. on Mondays to Fridays and between 8.30 and 1.30 p.m. on Saturdays (except on Christmas Day, Good Friday and Bank Holidays);
- (h) to provide that certain other vehicles may wait free of charge in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), and vehicles left by specified disabled persons (no time limit).

#### WESTMINSTER CITY COUNCIL

*The City of Westminster (Waiting and Loading Restriction) (Amendment No. ) Order 199*

*The City of Westminster (Parking Places) (No. ) Order 199*

Notice is hereby given that the Westminster City Council propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

The general effect of the Waiting and Loading Amendment Order would be to further amend the City of Westminster (Waiting and Loading Restriction) Order 1976 so that in the lengths of street specified in Schedule 1 to this Notice the hours of operation of the existing prohibition on:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be changed so that it would apply between 8.30 a.m. and 6.30 p.m. on Mondays to Fridays and between 8.30 a.m. and 1.30 p.m. on Saturdays;

- (b) waiting by vehicles for more than 20 minutes in the same place for the purpose of delivering or collecting goods or loading or unloading a vehicle would be changed so that it would be prohibited between 11 a.m. and 6.30 p.m. on Mondays to Fridays and 11 a.m. and 1.30 p.m. on Saturdays.

The general effect of the Parking Places Order would be to:

- (a) provide 2 hour metered parking places in Craven Road;
- (b) provide that in the residents' parking place, vehicles displaying a valid parking card bearing the letter "B" issued by the City Council in respect of that vehicle may be left. The charge for their use would be 70 pence per day unless a valid season ticket is displayed. Season ticket cost £20 for 3 months or £71 for 12 months.
