### DEPARTMENT OF TRANSPORT

#### TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of areas of Highway at Rosehill Terrace, Wallsend, Tyne & Wear.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Ian Darby Partnership for Leech Homes by North Tyneside Council on 21st December 1994, under reference NT/1552/94DM.

The proposed Order will provide that the stopping-up must not be carried out until new highway has been provided and that Highway shall be highway maintainable at the public expense for which North Tyneside Council will be the local highway authority.

Copies of the draft Order and relevant plan may be inspected at all reasonable hours during 28 days commencing on 28th June 1995, at the offices of North Tyneside Council, High Street West, Wallsend, Tyne & Wear, and may be obtained, free of charge, from the Department of Transport (quoting reference DN5038/35/1/448) at the address stated below.

Any person may object to the making of the proposed Order within the period of 28 days commencing on 28th June 1995, by notice to the Secretary of State for Transport, quoting the above reference, at the office of the Director Environment and Transport, Government Office for the North East, Wellbar House, Gallowgate, Newcastle-upon-Tyne NE1 4TD.

In preparing an objection it should be borne in mind that the substance of it may be imparted to other persons who may be affected by it and that those persons may wish to communicate with the objector about it.
