Notice is hereby given that Hampshire County Council proposes making a Road Traffic Regulation Order as follows:

*Effect of Order:* Waiting Restrictions on those lengths of road at Fleet are specified as follows:

*Lengths of road at Fleet in the District of Hart—No waiting at any time*

*Knoll Close*, both sides between its junction with Knoll Road and a point 10 metres west thereof.

*Knoll Road*, both sides between its junction with Fleet Road and a point 151 metres east thereof.

*Lengths of road at Fleet in the District of Hart—Waiting limited to 2 hours return prohibited within 1 hour 8 a.m. to 7 p.m. Mon-Fri*

*Knoll Road* from a point 151 metres northwest then north east of its junction with Fleet Road to a point 9 metres south of Elvetham Road.

Exemptions will be included for loading and unloading and disabled drivers parking.

*The Harrogate (On-street Parking Places) (Amendment No. 2) Order 1995*

 Prohibition of Waiting Variation Order 1995*

## SCHEDULE

## PART 1 — PROHIBITION OF WAITING

*Easington Road*—That length of road on its east side from its junction with Holdforth Road for a distance of 40 metres in a northerly direction.

*Holdforth Road*—

That length of road on its northerly side from its junction with Easington Road in an easterly direction to a point 16 metres east of the General Hospital entrance a total distance of approximately 305 metres.

The length of road on its southerly side from a point 145 metres east of its junction with Easington Road in an easterly direction for a distance of approximately 58 metres.

That length of road on its northerly side from a point 43 metres west of its junction with Wells Avenue to a point 15 metres east of its junction with Well's Avenue a total distance of 64 metres.
