The QUEEN has been graciously pleased to ordain and declare that Peter Hugh Charles Stanley, brother of Edward Richard William, Earl of Derby, shall henceforth have, hold and enjoy the same title, rank, place, pre-eminence and precedence which would have been due to him had his father the Honourable Hugh Henry Montagu Stanley survived his brother Edward John, Earl of Derby, and thereby succeeded to the title and dignity of Early of Derby;

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms. (2 SI)
