Proposed Pedestrianisation of Bath Street, Weymouth, Dorset

- (d) for Highway Authority or Council purposes;
- (e) for building maintenance operations or removals in Bath Street following prior arrangement with the Engineer's Department of the Borough Coucil;
- (f) by residents in receipt of a mobility allowance; or
- (g) for funerals.

The A19 Trunk Road (A19/A64 Interchange Improvement) Order

The A19 Trunk Road (A19/A64 Fulford Interchange Improvement Side Roads) Order 19

The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders:

1. An Order under sections 10 and 41 of the Highways Act 1980 which will:

- (1) provide that roads which he proposes to construct along the following routes shall become trunk roads from the date when the Order comes into force—
 - (a) The route of the first main new road is a route ("a main route") about 81 metres in length from a point on the western side of the A19 Trunk Road 122 metres south of the centre line of the A64 Trunk Road overbridge at Fulford to a point on the western boundary of A19 Trunk Road 64 metres south of the centre line of that overbridge (marked A on the deposited plan).
 - (b) The route of the second main new road is a route ("a main route") about 107 metres in length from a point on the western boundary of the A19 Trunk Road 99 metres north of the centre line of the A64 Trunk Road overbridge at Fulford to a point on the eastern boundary of the A19 Trunk Road 73 metres north of the centre line of that overbridge (marked B deposited on the plan).
 - (c) Four routes for slip roads and roundabouts to connect the main routes with other highways at Fulford.

2. An Order under section 14 of the Highways Act 1980, in relation to the A19 Trunk Road at Fulford in the County of North Yorkshire, which will:

(1) authorise him to---

(a) improve a highway,

(b) stop up highways,

all at Fulford in the vicinity of the new main roads on the main routes; and

(2) provide for the transfer of each new highway to the North Yorkshire County Council as highway authority as from the date on which he notifies them that it has been completed and is open for traffic.

3.
