

LONDON BOROUGH OF BARNET

*The Barnet (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. ) Order 1995*

*The Barnet and Brent (Restriction of Waiting on Bus Stops) (No. 1, 1974) (Amendment No. ) Traffic Order 1995*

*The Barnet (Greater London, Prohibition of Stopping on Cab Ranks) (Amendment No. ) Traffic Order 1995*

Notice is hereby given that the Council of the London Borough of Barnet propose to make the above-mentioned Orders under sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The general nature and effect of the Orders would be as follows:

- (a) the Waiting and Loading Restriction Amendment Order would amend the Barnet (Waiting and Loading Restriction) (Special Parking Area) Order 1994, so that:
  - (i) the times during which the existing restrictions on waiting by vehicles apply in the lengths of streets specified in Schedule 1 to this notice would be changed to the times stated in column 2 of that Schedule;
  - (ii) additional restrictions are placed on waiting by vehicles in the lengths of streets specified in Schedule 2 to this notice during the times stated in column 2 of that Schedule;
  - (iii) the lengths of restrictions on waiting by vehicles in certain parts of Hale Lane, Manor Park Crescent, Peshurst Gardens and Station Road, Edgware, would be changed;
  - (iv) the existing restrictions on loading by vehicles during the times of 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. on Mondays to Fridays in the length of street specified in Schedule 3 to this notice would be revoked;
- (b) the Restriction of Waiting on Bus Stops Amendment Order would amend the Barnet and Brent (Restriction of Waiting on Bus Stops) (No. 1) Traffic Order 1974, so that the areas specified as bus stops in Station Road, Edgware, by that Order would be varied to those defined in Schedule 4 to this notice and the times during which the restrictions on waiting would apply to those re-defined bus stops would be changed to the times stated in column 2 of that Schedule;
- (c) the Greater London Prohibition of Stopping on Cab Ranks Amendment Order would amend the Greater London (Prohibition of Stopping on Cab Ranks) Traffic Order 1979, so that the prohibition imposed by the Order on Peshurst Gardens in the London Borough of Barnet no longer applies.

A copy of the proposed Orders, other relevant Orders, a plan showing the locations and effects of the Orders and the Council's statement of reasons for proposing to make the Orders can be inspected between 9 a.m. and 5 p.m. on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date on which this notice is published at:
