Notice is hereby given that North West Water Limited ("the Company") is applying to the Secretary of State for the Environment for an Order under sections 73 and 74 of the above Act to reduce temporarily (ie, until 29th February 1996) the quantity of compensation water which the Company is required to discharge as follows:

The Company is normally required to discharge from the Hurstwood Reservoir into Thornden Clough or Hurstwood Brook 295,000 gallons (1.34 megalitres) of water per day.

This application is to reduce temporarily (until 29th February 1996) this quantity of compensation water to 0.8 megalitres per day.

A map showing the location of Hurstwood Reservoir and Brook may be inspected free of charge at Burnley Library, Grimshaw Street, Burnley BB11 2BD, for a period of seven days from the publication of this notice.
