Notice of application for consent, in pursuance of Schedule 10

Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991, that an application has been made to the National Rivers Authority, Anglian Region by Anglian Water Services Limited for consent to discharge sewage effluent in an emergency. The application is for a consent to discharge up to a maximum of 1,055 cubic metres per day of sewage effluent in an emergency from Flegg Green Pumping Station, Wereham, Norfolk, into an unnamed drainage ditch with a Dry Weather Flow, of 154 cubic metres per day.

The watercourse has no recognised uses. It is a tributary of the Cut-Off Channel and close to Wretton Fen SSSI which is of geological value. Consent is sought for an emergency overflow in the event of mechanical or electrical breakdown. Facilities are provided at the station to minimise the change of a discharge being made. These include a standby pump, a socket for a mobile generator and 4-83 hours storage at Dry Weather Flow. The outfall is provided to prevent flooding upstream of the pumping station in the event of mechanical or electrical failure.

Flegg Green Pumping Station is within the Borough of King's Lynn and West Norfolk and Norfolk County Council areas.
