## MISCELLANEOUS PUBLIC NOTICES

### NATIONAL RIVERS AUTHORITY

#### SALMON AND FRESHWATER FISHERIES ACT 1975

Pursuant to section 25 of and Schedule 2 to the Salmon and Freshwater Fisheries Act 1975, the National Rivers Authority ("NRA") hereby gives notice of its intention to fix new fishing licence duties which will have effect throughout the NRA's area of jurisdiction. It is intended that the duties set out below will come into force on 1st April 1996.

*Instrument:* Rod and Line.

*Period:* For a period of 12 months with effect from 1st April 1996.

*Area:* All waters within the fisheries jurisdiction of the National Rivers Authority.

*Duty:*

(i) Salmon, migratory trout (sea trout), non-migratory trout, char, freshwater fish (coarse fish) and eels.

Full annual charge: £55, Concessionary charge: £27.50

(ii) Non-migratory trout, char, freshwater fish (coarse fish), and eels.

No change to duties.

NOTE:

1. The concessionary charge will apply to:

(a) persons who have reached the age of 12 but have not reached the age of 17 on the date of purchase of the licence.

(b) persons aged 65 years or older,

(c) persons in receipt of;

(i) long term incapacity benefit,

(ii) short term incapacity benefit (at the higher rate),

(iii) severe disablement allowance,

(iv) war pension which includes unemployment supplement.

2. Temporary licences for 8 days and 1 day, for both types of licence, will be available from 1st April 1996 at a charge of:

(i) Salmon, migratory trout (sea trout), non-migratory trout, char, freshwater fish (coarse fish) and eels.

8 days £15 1 day £5

(ii) Non-migratory trout, char, freshwater fish (coarse fish), and eels.

No change to duties.

3. Subject to byelaws, a licence allows the use of up to two rods at the same time when fishing for freshwater fish and eels.

The NRA has also proposed new net licence duties for migratory salmonids, details of which can be obtained from: The Fisheries Officer, National Rivers Authority, Rivers House, Waterside Drive, Aztec West, Almondsbury, Bristol BS12 4UD.
