Notice of Temporary Prohibition of Traffic for Works

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

St. Paul's Road and Corsica Street (Islington) Temporary Prohibition of Traffic Order 1995

The Traffic Director for London, following a direction given to him by the Secretary of State for Transport under section 58(1) of the Road Traffic Act 1991, having made a request to the Council of the London Borough of Islington under section 58(5) of that Act having given a direction to that Council under section 58(6) of that Act, in accordance with section 58(7) of that Act in exercise of that Council's powers under section 14 of the Road Traffic Regulation Act 1984, and of all other enabling powers, hereby gives notice of his intention to make an Order as follows:

1. The Traffic Director for London is satisfied that traffic on the roads, or lengths of road, mentioned in the Schedule below should be prohibited as specified in paragraph 2 below because works are being or are proposed to be executed on or near those roads or lengths of road.
2. Save as provided in paragraph 3 below, during the period starting at 00.00 hours on 17th October 1995, for a period of three months or when those works have been completed, whichever is the sooner, no person shall cause or permit any vehicle to enter or proceed in the lengths of road specified.
3. (1) The prohibitions specified in paragraph 2 above shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs specified by regulations or authorised under section 64 of the Road Traffic Regulation Act 1984.
- (2) The prohibitions specified in paragraph 2 above shall not apply in respect of:
 - (i) any vehicle being used for the purpose of those works, or for fire brigade, ambulance or police purpose, or
 - (ii) anything done with the permission or at the direction of a police constable in uniform or a traffic warden, or
 - (iii) a vehicle being used to gain access to, or egress from, any premises adjacent to any of the roads or lengths of road mentioned in the Schedule to this Order.

4. At such times as the prohibition is indicated in accordance with paragraph 3 above then an alternative route shall be indicated by traffic signs specified by the Traffic Signs Regulations and General Directions 1994, on the following roads:

- (i) St. Pauls Road.
- (ii) Corsica Street, Highbury Grove, Baalbec Road, Calabria Road and Highbury Place.
