The application is for a Consent to Discharge up to a maximum of 1,917 cubic metres per day of sewage effluent from Stoke Ferry Sewage Treatment Works, Norfolk, into a tributary of the Red Gate Drain, at National Grid Reference TL 7009 9949, with a Dry Weather Flow of 282 cubic metres per day and a maximum flow to full treatment of 736 cubic metres per day.

Stoke Ferry Sewage Treatment Works is currently consented for a discharge of treated sewage effluent with a Dry Weather Flow of 184 cubic metres per day, a maximum flow to full treatment of 482 cubic metres per day, plus a discharge of storm sewage. This application is to allow for an increase in flow as a result of the Wereham S98 sewerage scheme, which includes the construction of the new Flegg Green Terminal Pumping Station, Wereham.

The above-mentioned Order reduces temporarily (i.e. until 31st October 1995) the quantity of compensation water which the Company is required to discharge from Jumbles Reservoir or from streams feeding it into Bradshaw Brook from 20 megalitres (5.646 cubic feet per second) to 12 megalitres per day.
