The County of Dorset (Various Roads, Corfe Mullen) (Prohibition of Waiting and Limited Waiting) Order 199

Notice is hereby given that Dorset County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984

The effect of the Order will be to:

- (a) prohibit waiting at any time on the following lengths of road in Corfe Mullen:
 - (i) Springdale Road:

(1) on its southern side from its junction with Wareham Road for a distance of 34 metres east thereof:

(2) on its northern side from a point 15 metres east of its junction with Wareham Road to a point 19 metres east thereof.

- (ii) Wareham Road on its eastern side from its junction with Springdale Road for a distance of 58 metres south to its junction of Corfe Lodge Road.
- (iii) Albert Road:

- (b) Limit waiting to one hour (return prohibited within one hour) between the hours of 9 a.m. and 6 p.m., Monday to Saturday on Wareham Road:
 - (1) on its eastern side from a point 21 metres south of its junction with Queens Road to a point 100 metres south thereof;
 - (2) on its eastern side from a point 23 metres south of its junction with Albert Road to a point 102 metres south thereof.

Exemptions will permit waiting for picking up or setting down passengers, loading or unloading goods, public service vehicles (whilst operating as a local service) at bus stops, disabled persons vehicles bearing the relevant orange badge, post office vehicles delivering and collecting mail, emergency service vehicles and vehicles in connection with any building or demolition operation, the maintenance of the road, the supply of gas, water or electricity and works to any telegraphic line.

The Mid Glamorgan County Council (Unnamed Road adjacent to Station Terrace, Llwynypia) (Prohibition of Waiting) Order 1995

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984, the effect of which will be:
