#### GREAT GRIMSBY BOROUGH COUNCIL

*The Borough of Great Grimsby (Colin Avenue and Macaulay Street) (School Keep Clear) Experimental (No. 95-6) Order 1995*

Notice is hereby given that the Great Grimsby Borough Council, acting as agent for the Highway Authority, the County Council of Humberside, on 16th October 1995, made a Road Traffic Regulation Order under powers contained in the Road Traffic Regulation Act 1984, which will come into operation on 30th October 1995, for a maximum period of 18 months.

The Borough Council will consider in due course whether the provisions of the Order should continue in force indefinitely.

The effect of the Order is to prohibit waiting between 8.30 a.m. and 9.30 a.m. and 3 p.m. to 4 p.m., Monday to Friday in school keep clear areas in the following length of road and on the following side of length of road:
