#### HEREFORD AND WORCESTER COUNTY COUNCIL

*The County of Hereford and Worcester (A4184 Abbey Road and Abbey Lane, Evesham) (Prohibition of Waiting) Order 1995*

Notice is hereby given that, on 19th October 1995, Hereford and Worcester County Council made an Order which will prohibit waiting at any time on the following lengths of roads in Evesham:

1. *A4184 Abbey Road*, the west side, from a point 45 metres south of its junction with the southern edge of Merstow Green for a distance of 117 metres in a southerly direction; the west side, from a point 15 metres north of its junction with Abbey Lane to a point 15 metres south of that junction; the east side, from its junction with the south side of Abbey Gardens for a distance of 107 metres in a southerly direction; and the east side, from a point 15 metres north of its junction with Abbey Lane to a point 15 metres south of that junction;
2. *Abbey Lane*, both sides, from its junction with A4184 Abbey Road for a distance of 15 metres in a westerly direction.

The Order will come into operation on 30th October 1995.
