The A465 Trunk Road (Merthyr Tydfil, Mid Glamorgan) (Prescribed Route and Prohibition of Right Hand Turn) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit any vehicle-

- entering the A465 Neath-Abergavenny Trunk Road at Merthyr Tydfil in the county of Mid Glamorgan (hereinafter referred to as "the trunk road"), via the eastbound trunk road entry slip road from the Pant Industrial Estate from proceeding in any direction other than eastwards; and
- proceeding in an easterly direction in the trunk road from making right hand turns into the westbound trunk road exit slip road leading to Rocky Road.
