HIGHWAYS ACT 1980

The East Sussex County Council (Hastings Spur Road Phase 2 Classified Road) (Side Roads) Order 1995

Notice is hereby given that East Sussex County Council give notice that they have made, and submitted to the Secretary of State for Transport for confirmation, an Order under sections 14 and 125 of the Highways Act 1980 authorising the Council:

- (a) to carry out the improvement of highways;
- (b) to stop up highways;
- (c) to construct new highways;
- (d) to stop up private means of access to premises; and
- (e) to provide new means of private access to premises,

all on or in the vicinity of the Hastings Spur Road (Phase 2), a classified road which the Council are proposing to create by improving parts of the existing road and by constructing a new section of road in the Borough of Hastings from the junction of Harley Shute Road, Ironlatch Avenue and Crowhurst Road to the junction of Sedlescombe Road South, Springfield Road and The Green.

Copies of the Order and the deposited plan may be inspected, free of charge, at all reasonable hours from Friday, 27th October 1995 to Friday, 8th December 1995 inclusive at:

NATIONAL RIVERS AUTHORITY (WELSH REGION)

SALMON AND FRESHWATER FISHERIES ACT 1975

Review of Net Limitation Orders

Following a review by the Welsh Region of the National Rivers Authority of the following Net Limitation Orders:-

1. *The Welsh Water Authority (Limitation of Net Fishing Licences) (Menai Strait) Order 1986*, which expires on 28th August 1996; and
2. *The Welsh Water Authority (Limitation of Net Fishing Licences) Order 1985*, which expires on 10th December 1995 ("the 1985 Order");

the National Rivers Authority made 20 Net Limitation Orders under section 26 of the Salmon and Freshwater Fisheries Act 1975, in January 1995. These were submitted to the Secretary of State for

Wales for confirmation in June 1995. Each Order limits the number of net licences which may be issued by the Authority for fishing, in those parts of the Authority's area to which the Order applies, for salmon or trout other than rainbow trout and sets out the method of application for and allocation of net licences.

On 19th October 1995, the Secretary of State for Wales informed the National Rivers Authority that he would be causing a local inquiry to be held into the following of the 20 Net Limitation Orders referred to above:

- (a) *The National Rivers Authority (River Dee) (Limitation of Net Fishing Licences) Order 1995;*
- (b) *The National Rivers Authority (River Usk and Bristol Channel) (Limitation of Net Fishing Licences) Order 1995;*
- (c) *The National Rivers Authority (Rivers Eastern and Western Cleddau) (Limitation of Net Fishing Licences) Order 1995;* and
- (d) *The National Rivers Authority (River Teifi) (Limitation of Net Fishing Licences) Order 1995.*

The result is that as these Orders will not take effect unless and until they are confirmed by the Secretary of State following the local inquiry, fishing for salmon or trout other than rainbow trout with an instrument other than rod and line in the river Dee, the river Usk and the Bristol Channel, the rivers Eastern and Western Cleddau, and the river Teifi, will shortly be unregulated by Net Limitation Orders as the 1985 Order expires on 10th December 1995.

Notice is hereby given that the National Rivers Authority has therefore made the following Net Limitation Order under section 26 of the Salmon and Freshwater Fisheries Act 1975:-

The National Rivers Authority (Limitation of Net Fishing Licences) Order 1995

The Order continues for a further two years the relevant provisions in the 1985 Order so as to maintain the status quo whilst the local inquiry is held and the Inspector's report considered, with the exception that the dates for the application and allocation of fishing licences, pursuant to the Order, have been changed from 1st November and 15th December to 31st December and 15th February the following year respectively.

Notice is hereby further given that it is the intention of the Secretary of State for Wales to confirm this Order.

Copies of the Order have been deposited at the offices of the Authority at the addresses given below and will be open to inspection, free of charge, from Monday to Friday during normal office hours from the date of this notice until Friday, 17th November 1995.
