Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991, that an application has been made to the National Rivers Authority, Anglian Region, by Redland Aggregates Limited, Redland House, Reigate, Surrey RH2 0SJ, for consent to discharge up to 5,000 cubic metres per day of trade effluent derived from the dewatering of mineral workings from Great Waltham Gravel Pit, Broads Green, Great Waltham, Chelmsford, Essex. Notice of applications for licences to abstract water

Notice is hereby given that applications are being made to the National Rivers Authority by ARC Ltd., of The Ridge, Chipping Sodbury, Bristol BS17 6AY, for two licences, both to be operated in the parishes of Needingworth and Bluntisham, Cambridgeshire, which are outlined as follows:

(a) *River Abstraction Licence*

It is proposed to abstract water from the west bank of the River Great Ouse and transfer it to operational lagoons owned and used by ARC Ltd. Abstraction from the River Great Ouse will be made at NGR TL 3640 7190, and will entail:

- (i) Use 1 for make-up water in mineral washing rates of: 42 cubic metres per hour, 1,000 cubic metres per day, 244,000 cubic metres per annum during the period October to May each year.
- (ii) Use 2—Seasonal augmentation to effect replenishment of lagoons and localised recharge of groundwater at total rates of: 375 cubic metres per hour, 9,000 cubic metres per day, 220,000 cubic metres per annum during the period November to April each year.

(b) *Groundwater Abstraction Licence*

It is proposed to abstract groundwater from the Sand and Gravel aquifer by means of:

Operational lagoons and pits located within NGR enclosure of: TL 3630 7195, TL 3605 7205, TL 3615 7230, TL 3560 7245, TL 3570 7265, TL 3515 7275, TL 3505 7190, TL 3585 7140; an array of tubewells located within the NGR enclosure of: TL 3640 7280, TL 3685 7270, TL 3620 7230, TL 3660 7230.

YORKSHIRE WATER SERVICES LIMITED

Application for Drought Order, River Wharfe (Arthington)

Notice is given that Yorkshire Water Services Limited ("the Company") is applying to the Secretary of State for the Environment for an Order (to remain in force for 3 months) under section 75 of the Water Resources Act 1991 authorising a temporary modification of the Company's licence authorising the Company to abstract water from the River Wharfe at Arthington at National Grid Reference SE 263454.

The existing abstraction conditions permit the Company to abstract up to 100,000 cubic metres per day during any time when the flow in the River Wharfe is greater than 580,000 cubic metres per day as measured at the gauge at Addington Low Mill (National Grid Reference SE 092494).

The order if granted would authorise the following:

- (a) the Company to abstract up to an amount equivalent to the quantity released from Lindley Wood Reservoir during anytime when the flow of water in the River Wharfe as measured above is less than 170,000 cubic metres per day;
- (b) the Company to abstract up to 50,000 cubic metres per day during anytime when the flow of water in the River Wharfe as measured above is less than 580,000 cubic metres per day but equal to or greater than 170,000 cubic metres per day; and
- (c) the Company to abstract up to 100,000 cubic metres per day during anytime when the flow of water in the River Wharfe as measured above is equal to or greater than 580,000 cubic metres per day (as permitted under the existing abstraction licence).
