

- (i) Provide NRA as the pollution control authority with full information about all samples of treated water, taken in accordance with the Water Supply (Water Quality) regulations 1989, and untreated water, relevant to the Clarendon Direct and Salisbury Water Supply Zones, taken and analysed for pesticides so that pollution control measures can be considered. This information to include details of location and timing of the sample, the pesticides investigated and the source of the water and the date of abstraction. To continue for the duration of the undertaking. This information to be provided quarterly within 28 days of the end of the quarter, in the case of a marked increase in concentration or the identification of a pesticide not previously present, so far as is reasonably practicable, within 28 days of the sample being taken.
- (b) Appraise the feasibility of blending supplies from Clarendon, Devises Road and Deans farm treatment works (at Cockey Down Service Reservoir) in order to achieve compliance within the Clarendon supply area. To be completed by 30th November 1995.
- (c) In the light of the appraisal in (b) either:
- (i) Install facilities to blend supplies from Clarendon, Devises Road and Deans Farm treatment works at Cockey Down service reservoir to secure compliance. To be completed by 31st December 1996.
and/or
- (ii) Install facilities to remove Clarendon treatment works from supply during period of high ground water levels and/or pesticides to secure compliance. To be completed by 31st December 1996.
and/or
- (iii) install treatment to secure compliance. To be completed by 31st December 1997.
- (d) In conjunction with the NRA promote and facilitate a policy of catchment control and protection. To be continued for the duration of the undertaking.
- (e) If pesticide concentration approaches or exceeds advisory value specified on pages 95-105 of "Guidance on Safeguarding the Quality of Public Water Supplies" or notified by DWI:
- (i) Provide DWI with information specified in (a)(i). To be completed as soon as analytical results are available, and as soon as is reasonably practicable, not more than 28 days of the sample being taken.
- (ii) Notify NRA, as in (a)(i). To be completed as soon as analytical results are available, and as soon as is reasonably practicable, not more than 28 days of the sample being taken.
- (iii) Carry out sampling and, if investigations show that pollution is of a long standing nature, consider the temporary provision of an alternative supply of potable water. To be completed as necessary.
4. is satisfied that Wessex Water Services Limited has given and is complying with an undertaking to take all steps as appear to the Secretary of State for the time being to be appropriate to secure or facilitate compliance with the requirement of Regulations 3(3)(c) of the Water Supply (Water Quality) Regulations 1989.
