#### **CUSTOMS AND EXCISE**

Notice of seizure under the Customs and Excise Management Act 1979

To: Robert Tristram Greenwood or the owner of a Volvo Lorry registration number F33 TEV

Pursuant to section 139(6) of the Customs and Excise Management Act 1979, and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the Customs and Excise Acts, a vehicle namely:

One Volvo lorry bearing the registration number F33 TEV

has been seized as liable to forfeiture by force of the following provisions namely:

Sections 49 and 141 of the Customs and Excise Management Act 1979.

If you claim that the said vehicle is not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 to the Customs and Excise Management Act 1979.

If you are outside the United Kingdom and the Isle of Man you

must also give the name and address of a Solicitor in the United Kingdom who is authorised to accept service of process and act on

If you do not give notice of claim within the said period of one month or, if any requirement of the above-mentioned paragraph 4 is not complied with, the vehicle in question will be deemed to have been duly condemned as forfeit.

If you do give notice of claim in proper form, the Commissioners will take legal proceedings for the condemnation of the said goods.
