TOWN AND COUNTRY PLANNING ACT 1990

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of the whole of Newtown Street south of Battersea Park Road and north of Strasburg Road, the whole of the north-eastern arm of Strasburg Road, a length and a part of the western footway of Strasburg Road, the whole of the western footway and two parts of the un-named highway adjoining the eastern side of that length of Alfreda Street south of Battersea Park Road and north of Strasburgh Road, two areas of highway land to the south of Battersea Park Road, the whole of the un-named footpath to the south and to the west of Bank Court and the whole of the un-named footpath on the western side of Park Court on the Doddington Estate, Battersea, London S.W.11.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the deemed planning permission granted by the London Borough of Wandsworth on 15th March 1994, under reference 93/N/0475.

The proposed Order will require the London Borough of Wandsworth to provide two new footpaths and that those footpaths shall be highways maintainable at the public expense for which the London Borough of Wandsworth will be the local highway authority.
